OPENING: The meeting was called to order by Planning Administrator Anthony J. Zappasodi, Esg. at 7:31 PM.

PLEDGE OF ALLEGIANCE: Led by Planning Administrator Zappasodi.

OPMA STATEMENT: Read by Planning Administrator Zappasodi in compliance with the Sunshine Law.

The Zoning Board of Adjustment "Agenda Policies and Procedures" were read by Mr. Zappasodi and confirmed for continued use in 2014.

Solicitor Zeller administered the Oath of Office to Mr. Rardin as a Regular Zoning Board Member.

ADMINISTRATIVE ITEMS - Reorganization

Election of Chair. Mr. Zappasodi asked for nominations for Chairperson for the year 2014. Mrs. Farhat nominated Jonathan Rardin to serve as Chairperson and was seconded by Mrs. Rovner, with affirmative votes by Maitland, Rovner, Carter, Schmoll, DiRenzo, and Biviji. Abstention by Mr. Rardin. Motion carried.

Election of Vice Chair. Chairperson Rardin asked for nominations for Vice-Chairperson for the year 2014. Mr. DiRenzo nominated Farhat Biviji to serve as Vice-Chairperson and was seconded by Mrs. Rovner, with affirmative votes by Maitland, Rovner, Carter, Schmoll, DiRenzo, and Rardin. Abstention by Mrs. Biviji. Motion carried.

Appointment of Secretary. Chairperson Rardin asked for nominations for Secretary for the year 2014. Mr. Maitland nominated Paul Stridick, AIA to serve as Secretary and was seconded by Mr. DiRenzo, with affirmative votes by Maitland, Rovner, Carter, Schmoll, DiRenzo, Biviji, and Rardin. Motion carried.

Appointment of Alternate Secretary. Chairperson Rardin asked for nominations for Alternate Secretary for the year 2013. Mr. Carter nominated Anthony Zappasodi, Esq. to serve as Alternate Secretary and was seconded by Mr. DiRenzo, with affirmative votes by Maitland, Rovner, Carter, Schmoll, DiRenzo, Biviji, and Rardin. Motion carried.

Adoption of Zoning Board Bylaws, Mrs. Rovner made a motion to approve the 2014 Bylaws, which was seconded by Mr. Schmoll, with affirmative votes by Maitland, Rovner, DiRenzo, Carter, Schmoll, Biviji, and Rardin. Motion carried.

Establishment of Meeting Dates and Adoption of Official Newspaper. Mr. DiRenzo made a motion to approve the Courier-Post as the designated newspaper for 2014, which was seconded by Mr. Carter, with affirmative votes by Maitland, Rovner, Carter, Schmoll, DiRenzo, Biviji, and Rardin. Motion carried. Zoning Board of Adjustment Annual Report - 2013. Mrs. Rovner made a motion to accept and approve the 2013 Annual Report of the Zoning Board with a suggested revision on page five to #3 under the

"Recommendations" section so as to include language that the fee schedule "will be brought into alignment with other similar local Townships, the Department of Community Development's past practices, and not be excessive", which was seconded by Mr. DiRenzo, with affirmative votes by Maitland, Rovner, DiRenzo, Carter, Schmoll, Biviji, and Rardin. Motion carried.

Appointment of Solicitor. Mr. Schmoll made a motion to nominate the law firm of Zeller & Wieliczko, LLP as Zoning Board Solicitor for 2014, which was seconded by Mrs. Rovner, with affirmative votes by Maitland, Rovner, DiRenzo, Carter, Schmoll, Biviji, and Rardin. Motion carried.

Appointment of Engineer. Mr. DiRenzo made a motion to nominate the engineering firm of Environmental Resolutions Inc. as Zoning Board Engineer for 2014, which was seconded by Mr. Maitland, with affirmative votes by Maitland, Rovner, DiRenzo, Carter, Schmoll, Biviji, and Rardin. Motion carried.
